Ramped C.I.C has a duty of care for all participants attending its activities. All sessions are supervised by experienced staff who are first aid trained.

Ramped C.I.C operates a strict code of practice which does not tolerate conduct or behaviour by participants, parents or children that is discriminatory, offensive, violent or dangerous.

To ensure participant and spectator safety & enjoyment we ask you to respect the following guidelines:

1. Participants must be aged between 10 – 30 years
2. No Alcohol or Drugs - Any participant suspected of using Alcohol or Drugs will be asked to leave. Please do not be offended if we ask you to leave.
3. Please ensure participants are wearing suitable clothing for the activity being undertaken and that they have the correct medication, if required e.g. inhaler. Ramped C.I.C will not be held responsible for loss or damage to personal possessions arising from the activity.
4. Some summer activities are delivered outdoors so please ensure that participants have sun cream and a hat to protect them from the sun.
5. Every effort will be made to ensure that young people do not leave sessions early unless the proper authorisation has been granted, however anyone who leaves against the express wishes of our staff or parents, does so at their own risk.
6. All participants must properly register before the start of each session and have a signed consent form (*overleaf*). In the case of children & young people under 18 years the signature of an adult with parents/guardians status for that child must be supplied. Failure to comply with our registration and release procedures may result in exclusion from this or future sessions. Ramped C.I.C does not accept responsibility for participants on their journey to and from the sessions.
7. As some activities are outdoors Ramped C.I.C reserves the right to cancel activities without prior notice although every effort will be made to notify participants if changes occur.
8. Once a session starts, and for the full duration of the session, only Ramped C.I.C staff and participants may enter the Riding area.
9. Ramped C.I.C reserves the right to exclude or refuse admission to any participant from any session on the grounds of:
 - (a) Disruptive, discriminatory, offensive or violent behaviour.
 - (b) Actions that may be considered to be a danger to them, coaching staff or other participants.
10. Any theft or malicious damage of equipment or physical/verbal assault to staff will be pursued to the full extent of the law.
